### I. Call to Order

Quorum was established and the meeting was called to order at 2:04 p.m.

# II. Public Testimony

Chair Murdock asked if anyone wished to make public testimony at this time. No responses made.

# III. Findings and Recommendations Report

Juha Kauhanen presented an overview of the Executive Summary for the Consolidation of IT Services; and states that the information being presented conveys the consensus among various committees regarding Act 179. Kauhanen touched on the intended benefits of the consolidation being economies of scale,

cost savings, and standardizing the service levels and the quality of services provided are the main goals of the consolidation.

Kauhanen shared a comparison of IT operating models (Decentralized, Coordinated, Centralized, and Hybrid Extended Shared Services) and discussed each model's suitability for the State. Kauhanen moves on to discuss the recommended model being the Hybrid Extended Shared Services model.

Kauhanen moved on to discuss the summary of recommendations for consolidation actions; highlighting cost benefit and timing, delivery capabilities, ongoing scheduled systems modernization, develop and offer new shared services in phases, execute infrastructure and facilities consolidation, analyze common (shared) enterprise applications for consolidation, calls for more collaboration and sharing of IT expertise across departments, staffing transitions, funding model, data governance, and workforce development and training.
